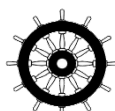

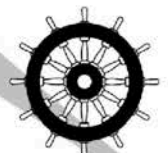

CONDITIONS OF CERTIFICATION RELATED TO THE END USER

The following conditions of certification are included in the Certificate No MED 1950006 and are related to the end user onboard vessels

- 1) The product is approved for use as part of a pilot transfer arrangement and associated equipment specified by SOLAS Reg. V/23
- 2) The arrangement and installation of the ladder on board are not part of the design appraisal or certificate and are to be to the satisfaction of the Surveyors attending on board
- 3) Each Ladder **must be subjected to a ladder and step attachment strength test** as per Table 2 of ISO799:2004 **at approximately 30-month interval**. Each ladder which fails the test shall be rebuilt or scrapped. The tested ladder must be stamped or tagged near the bottom of the ladder with the date of the test and the identification of the person or company performing the test. The Person or company performing the test shall also provide a test certificate for the owner of the ladder, indicating the details of the test, including the date and the identification of the person or company performing the test.
